



The Grand Jurors selected, chosen and sworn for the County of Glynn, to wit:

COUNT 1

In the name and behalf of the citizens of Georgia, charge and accuse **KYLE RYAN MORGAN** with the offense of **AGGRAVATED ASSAULT, FAMILY VIOLENCE** for that the said accused, **ON OR ABOUT THE 13TH DAY OF JANUARY, 2018**, in the County aforesaid, **DID KNOWINGLY MAKE AN ASSAULT UPON THE PERSON OF TERRA TYNER MORGAN WITH HIS HANDS, OBJECTS WHICH WHEN USED OFFENSIVELY AGAINST A PERSON ARE LIKELY TO RESULT IN STRANGULATION BY PLACING HIS HANDS AROUND SAID PERSON'S NECK AND APPLYING PRESSURE, SAID OFFENSE BEING COMMITTED BETWEEN PERSONS WHO WERE AT THE TIME OF THE OFFENSE SPOUSES, SAID ACT BEING SEPARATE AND DISTINCT FROM ANY OTHER COUNT IN THIS INDICTMENT**, all of said act being contrary to the laws of said State, the good order, peace and dignity thereof.

COUNT 2

And the Grand Jurors aforesaid, on their oaths aforesaid, in the name and behalf of the Citizens of Georgia, further charge and accuse **KYLE RYAN MORGAN** with the offense of **FALSE IMPRISONMENT** for that the said accused **ON OR ABOUT THE 13TH DAY OF JANUARY, 2018**, in the County aforesaid, **IN VIOLATION OF THE PERSONAL LIBERTY OF TERRA TYNER MORGAN, DID UNLAWFULLY DETAIN SAID PERSON WITHOUT LEGAL AUTHORITY, TO WIT: SAID ACCUSED WOULD NOT LET TERRA TYNER MORGAN LEAVE THE RESIDENCE IN WHICH THEY WERE LOCATED, SAID ACT BEING SEPARATE AND DISTINCT FROM ANY OTHER COUNT IN THIS INDICTMENT**, all of said act being contrary to the laws of said State, the good order, peace and dignity thereof.

COUNT 3

And the Grand Jurors aforesaid, on their oaths aforesaid, in the name and behalf of the Citizens of Georgia, further charge and accuse **KYLE RYAN MORGAN** with the offense of **CRUELTY TO CHILDREN IN THE THIRD DEGREE** for that the said accused **ON OR ABOUT THE 13TH DAY OF JANUARY, 2018**, in the County aforesaid, **BEING THE PRIMARY AGGRESSOR, DID INTENTIONALLY ALLOW [REDACTED] MORGAN, A CHILD UNDER THE AGE OF EIGHTEEN (18) YEARS, TO WITNESS THE COMMISSION OF THE OFFENSE OF AGGRAVATED ASSAULT, A FORCIBLE FELONY, UPON TERRA TYNER MORGAN, SAID ACT BEING SEPARATE AND DISTINCT FROM ANY OTHER COUNT IN THIS INDICTMENT**, all of said

COUNT 4

And the Grand Jurors aforesaid, on their oaths aforesaid, in the name and behalf of the Citizens of Georgia, further charge and accuse **KYLE RYAN MORGAN** with the offense of **CRUELTY TO CHILDREN IN THE THIRD DEGREE** for that the said accused **ON OR ABOUT THE 13TH DAY OF JANUARY, 2018**, in the County aforesaid, **BEING THE PRIMARY AGGRESSOR, DID INTENTIONALLY ALLOW [REDACTED] MORGAN, A CHILD UNDER THE AGE OF EIGHTEEN (18) YEARS, TO WITNESS THE COMMISSION OF THE OFFENSE OF AGGRAVATED ASSAULT, A FORCIBLE FELONY, UPON TERRA TYNER MORGAN, SAID ACT BEING SEPARATE AND DISTINCT FROM ANY OTHER COUNT IN THIS INDICTMENT,** all of said act being contrary to the laws of said State, the good order, peace and dignity thereof.

COUNT 5

And the Grand Jurors aforesaid, on their oaths aforesaid, in the name and behalf of the Citizens of Georgia, further charge and accuse **KYLE RYAN MORGAN** with the offense of **BATTERY, FAMILY VIOLENCE** for that the said accused **ON OR ABOUT THE 13TH DAY OF JANUARY, 2018**, in the County aforesaid, **DID INTENTIONALLY CAUSE VISIBLE BODILY HARM, TO WIT: A BLEEDING LIP, TO THE PERSON OF TERRA TYNER MORGAN, SAID PERSON BEING THE SPOUSE OF SAID ACCUSED AT THE TIME OF SAID OFFENSE, BY STRIKING SAID PERSON, SAID ACT BEING SEPARATE AND DISTINCT FROM ANY OTHER COUNT IN THIS INDICTMENT,** all of said act being contrary to the laws of said State, the good order, peace and dignity thereof.

COUNT 6

And the Grand Jurors aforesaid, on their oaths aforesaid, in the name and behalf of the Citizens of Georgia, further charge and accuse **KYLE RYAN MORGAN** with the offense of **BATTERY, FAMILY VIOLENCE** for that the said accused **ON OR ABOUT THE 5TH DAY OF APRIL, 2018**, in the County aforesaid, **DID INTENTIONALLY CAUSE VISIBLE BODILY HARM, TO WIT: RED MARKS, TO THE PERSON OF TERRA TYNER MORGAN, SAID PERSON BEING THE SPOUSE OF THE ACCUSED AT THE TIME OF SAID OFFENSE, BY PLACING HIS HAND AROUND THE THROAT OF SAID PERSON, SAID ACT BEING SEPARATE AND DISTINCT FROM ANY OTHER COUNT IN THIS INDICTMENT,** all of said act being contrary to the laws of said State, the good order, peace and dignity thereof.

COUNT 7

And the Grand Jurors aforesaid, on their oaths aforesaid, in the name and behalf of the Citizens of Georgia, further charge and accuse **KYLE RYAN MORGAN** with the offense of **CRUELTY TO CHILDREN IN THE THIRD DEGREE** for that the said accused **ON OR ABOUT THE 5TH DAY OF APRIL, 2018**, in the County aforesaid, **BEING THE PRIMARY AGGRESSOR, DID INTENTIONALLY ALLOW [REDACTED] MORGAN, A CHILD UNDER THE AGE OF EIGHTEEN (18) YEARS, TO WITNESS THE COMMISSION OF A FAMILY VIOLENCE BATTERY UPON TERRA TYNER MORGAN, SAID ACT BEING SEPARATE AND DISTINCT FROM ANY OTHER COUNT IN THIS INDICTMENT,** all of said act being contrary to the laws of said State, the good order, peace and dignity thereof.

COUNT 8

And the Grand Jurors aforesaid, on their oaths aforesaid, in the name and behalf of the Citizens of Georgia, further charge and accuse **KYLE RYAN MORGAN** with the offense of **TERRORISTIC THREATS** for that the said accused **ON OR ABOUT THE 5TH DAY OF APRIL, 2018**, in the County aforesaid, **DID WITH THE PURPOSE OF TERRORIZING ANOTHER, TO WIT: TERRA TYNER MORGAN, THREATEN TO COMMIT BATTERY, A CRIME OF VIOLENCE,** all of said act being contrary to the laws of said State, the good order, peace and dignity thereof.

And the Grand Jurors aforesaid, on their oaths aforesaid, in the name and behalf of the Citizens of Georgia, further charge and accuse **KYLE RYAN MORGAN** with the offense of **SIMPLE BATTERY, FAMILY VIOLENCE** for that the said accused **ON OR ABOUT THE 3RD DAY OF SEPTEMBER, 2018**, in the County aforesaid, **DID INTENTIONALLY MAKE PHYSICAL CONTACT OF AN INSULTING OR PROVOKING NATURE, TO WIT: SPITTING INTO THE FACE OF TERRA TYNER MORGAN, SAID PERSON BEING THE SPOUSE OF SAID ACCUSED AT THE TIME OF THE OFFENSE**, all of said act being contrary to the laws of said State, the good order, peace and dignity thereof.

COUNT 11

And the Grand Jurors aforesaid, on their oaths aforesaid, in the name and behalf of the Citizens of Georgia, further charge and accuse **KYLE RYAN MORGAN** with the offense of **BATTERY, FAMILY VIOLENCE** for that the said accused **ON OR ABOUT THE 3RD DAY OF SEPTEMBER, 2018**, in the County aforesaid, **DID INTENTIONALLY CAUSE VISIBLE BODILY HARM, TO WIT: RED MARKS, TO THE PERSON OF TERRA TYNER MORGAN, SAID PERSON BEING THE THE SPOUSE OF SAID ACCUSED AT THE TIME OF THE OFFENSE, BY STRIKING SAID PERSON IN THE THROAT, SAID ACT BEING SEPARATE AND DISTINCT FROM ANY OTHER COUNT IN THIS INDICTMENT**, all of said act being contrary to the laws of said State, the good order, peace and dignity thereof.


